The National Postal Policy Council (“NPPC”), the Association for Mail Electronic Enhancement (“AMEE”), the Association of Marketing Service Providers (AMSP), GrayHair Software, Inc. (GrayHair), the Greeting Card Association (“GCA”), the International Digital Enterprise Alliance, Inc. (“IDEAlliance”), the Major Mailers Association (“MMA”), and the National Association of Presort Mailers (“NAPM”) (collectively “Petitioners”) hereby respectfully move, pursuant to section 3001.21 of the rules of practice, for leave to file the “Reply In Support Of Petition” – filed concurrently herewith – to the “Answer of the United States Postal Service In Opposition To Petition To Initiate A Proceeding Regarding Postal Demand Analysis” filed on May 9.
